#### **Environment Data**

LandTracker Enviro improves access and visibility of environmental data and activities by maintaining all data in a centralized digital location. The data can be as detailed or brief as required and can be imported easily from MS Excel. All data in LandTracker Enviro is held within a Microsoft Azure SQL database.

The environment data links to:

- Digital documents on the network or document management system;
- Any other related environmental information;
- The tenement data related to the environmental project; and
- A map of the company's tenure related to the environmental data and any other tenure that may be in the vicinity.

# **Compliance and Reporting**

LandTracker Enviro demonstrates compliance with both regulatory conditions and internal standards. Environmental conditions can be consolidated, compliance tasks assigned, and alerts created for exceedances. Fully customisable reports can be generated automatically and emailed to any specified responsible party or management group. Critical dates can also be escalated up the chain of responsibility depending on the timeframe.

## **Action Management and Reporting**

LandTracker Enviro provides complete visibility of the status of critical actions and related tasks and creates a culture of responsibility through effective management of actions. Action dates with assignment details can be easily communicated via automated email notifications. A User can view responsibilities for assignments and completions across their entire team and engender overall assignment ownership and accountability. Customise task escalations and receive automated alert notifications of both pending and overdue actions

## **Mapping**

LandTracker Enviro has a mapping interface with the ability to show all tenements in Australia, along with 1:250,000 topographic map, satellite views, magnetics, gravity and geology.











Any group of selected tenements can be exhibited including any competitor's surrounding tenure. This can both streamline employee's reporting and improve the visibility of assets to all employees who will have a ready ability to visualise tenements and other assets on a mapping interface. E.g. Programmes of Work and other environmental areas.

## **Usability and Security**

LandTracker Enviro is a web integrated service that benefits from having access to desktop functionality, which allows access to local files, multiple screens and integration of Microsoft Office products like Word, Excel and Outlook. This enables simple copying and pasting to and from these products.

LandTracker Enviro provides access to data away from the office, by allowing location flexibility through a centralised database, which all desktop instances can connect to, whether located on an office PC or mobile laptop.

Along with editor access to LandTracker Enviro enables an unlimited number of users read-only access. Therefore, data can be available not only to environmental personnel but to Geologists, Accountants and administration staff as required. Robust security and database segregation controls access to information. For example, we are able to control access to different projects by permitting read only access to a particular project or module as required.
